Conferences for presentation of the final results of LIFE RE-WEEE project

The **LIFE RE-WEEE** project is completed on November 2020. In this context, two conferences were organized for the presentation of the final results and the achievements of the project. The two conferences took place as webinars and organized by the partners RREUSE and Hellenic Recycling Agency (HRA) respectively.

1st Conference:

A three-session Conference was successfully held on 9 and 12 of November, 2020, organized by RREUSE. The three sessions covered the following topics:

- **Session 1** - Developing a WEEE prevention, repair and re-use culture in Europe.
- **Session 2** – The development of standards and technical requirements for WEEE preparing for re-use activities.
- **Session 3**– WEEE prevention and preparing for re-use in the EU.



The Conference had 69 participants by 12 EU member states, covering a wide range of stakeholders. The participants, as well as the speakers, were representatives of the European Commission, local authorities, NGOs, Universities, Producer Responsibility Organisations, research institutes, auditors, EEE manufacturers and stakeholders by the whole stages of WEEE management chain. Following the presentations, debate among the stakeholders took place on the future of WEEE prevention and preparing for re-use in the EU, the project sustainability and the After Life actions.

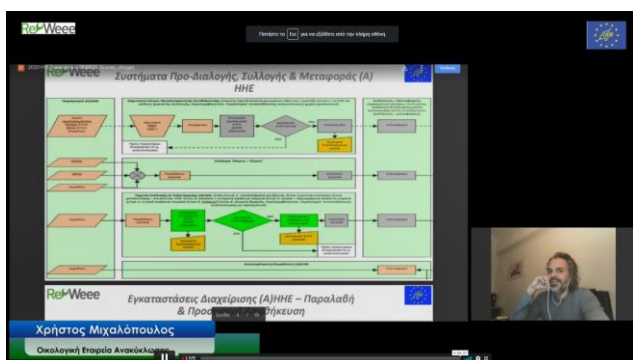
