3. Executive Summary

The inception of Project LIFE RE-WEEE - LIFE14 ENV/GR/000858 "Development and demonstration of Waste Electrical and Electronic Equipment (WEEE) prevention and reuse paradigms" was set on the 1st of January 2016, after the EC's approval of the proposal. The present Mid-term report constitutes the complete reporting of the Project implementation for the period time of January 2016 – September 2017, concerning the deliverables and the activities that took place during the period.

At the beginning of the Project, three (3) management groups (Project Management Group - PMG, Quality Assurance and Quality Control Group – QA/QC Group and Carbon Footprint Group – CFG) were established, in order to support the Administrative Council of the Project (ACP) to monitor and manage the Project implementation. During the reporting period, several meetings and contacts among the supporting groups were held, so as significant decisions could be taken, in order to facilitate the proper progress of the Project. The contribution of the management groups was crucial, in order to tackle issues that the Project team addressed.

During the current period, all "Implementation Actions" (Actions B) were in progress. The main activities that were foreseen to be implemented were the recording and comparison of existing EU measurement methodologies of re-use and preparing for re-use, the development of the collaborative platform Re(W)eee for donating and exchanging EEE, the organization of Consultation Foras with the participation of the Project stakeholders, the implementation of the tender procedure by the Green Fund (GF) for the Municipalities selection that the two (2) Sorting Centers (SCs) will operate, the development of an issue of general specifications for WEEE preparing for re-use stage and five (5) special specification issues for management of WEEE categories (except lamps) addressed to preparing for re-use, and the implementation of a tender procedure by "Appliances Recycling S.A" for the selection of the contractors that will operate the two SCs.

Within the reporting period, the evaluation and comparative analysis of the existing EU measurement methodologies of re-use and preparing for re-use, that were recorded through specific questionnaires addressed to stakeholders of all EU member states, took place to facilitate the development of an integrated methodology and a transferable measurement tool for preparing for re-use. The evaluation and comparative analysis is currently in draft phase.

The donation/exchange platform is already operated in beta version for five (5) months and will finally implemented in November. Representatives from the fields of Social Economy or Environment contributed to the final configuration of the platform, as potential recipients of the platform donations, by attending at the 2^{nd} Thematic Fora.

According to the approved proposal, 12 Consultation Fora (7 open Foras and 5 thematic Foras) will be organized in total. For the current period, 5 Foras have taken place (3 Open Foras and 2 Thematic Foras), and have exceeded the targeted number of participants. These Foras were crucial for the project progress, as the main topics discussed concerned the definition of SCs technical requirements and tackling of the barriers that have been addressed, the procedure for submission of the Municipalities proposals for SC infrastructures and the definition of the operation requirements of the donation/exchange platform.

Concerning the development of the specifications and the technical requirements for the entire "preparing for re-use" cycle, the 1st issue of specifications and technical requirements for collection, transfer, sorting and storage of WEEE and the issue of general specifications for WEEE preparing for re-use stage were delivered, constituting the base for the definition of the activities that will take place during the SCs operation. There is a delay of one (1) month for the development of this five (5) special specification issues for management of WEEE categories (except lamps) addressed to preparing for re-use, due to staff changes of HRA, the

















beneficiary responsible for the Action implementation, within the foreseen period for the aforementioned deliverable development.

There was a delay of five (5) months for the launch of the call of interest for the Municipalities election, due to legislative restrictions that the Project team addressed, concerning the authorization and spatial planning of SCs, as described in detail at the charter "6. Technical part" in the corresponding Action B.5. The final results of the call of interest for the Municipalities election for the SCs operation were announced by the GF on 31/7/2017. For the region of Central Macedonia, the Municipality of Oraiokastro garnered the highest rating within the evaluation procedure, for the operation of the 1st Waste Electrical and Electronic Equipment (WEEE) SC of Greece. For the Attica region no Municipality selection took place, since the unique candidate (consortium of Kifissia-Dionysus) did not submit the required technical report durig the 2nd phase duration of the tender procedure. To address the emerged constraint, "Appliances Recycling S.A.", the beneficiary responsible for the contractors' tender procedure, proceeded in the constitution of an integrated tender procedure for the operation of the SC in the Attica region through the selection of a combined contractor – infrastructure scheme, following the approval of the Project Adviser, Mrs. Anna Natasa Asik, on 27/7/2017. The object of the tender concerning the contractor for the SC operation of Oraiokastro is foreseen. The two (2) contractors' tenders (one for each region of interest) are conducted in parallel by "Appliances Recycling S.A." and will be announced in November 2017. The duration of the tendering procedure will last one (1) month and the evaluation of the submitted proposals is expected to take place in December 2017. The announcement of the contractors' tender will be delayed for 7 months, firstly due to the legislative restrictions that the Project faced, as forecasted above, and due to the one (1) month prolongation of the call of interest for the Municipalities selection, owing to the lack of attendees at the 1st phase of the tender at the Attica region.

Implementation Actions are followed by supporting actions, such as the state-of-the-art report (Action A.1), which was completed within the reporting period of the 1st Progress report of the project, and dissemination actions (Actions D), by providing the base for the requirements for SCs operation and development of the donation/exchange platform and with the communication of the project progress and result to public and stakeholders. Among the dissemination actions is the project's participation in relevant waste management conferences and workshops, the distribution of project newsletters and the continuing update of the LIFE RE-WEEE website with the project progress.

The Project progress is monitored and managed within Actions E ("Management and monitoring of project implementation progress"), concerning the project progress and the environmental impact, by calculation of CO₂ emissions, as prescribed in the approved Grant Agreement (GA). Project implementation is progressing smoothly, by finding viable solutions to the challenges faced in the project, as recorded in the monthly reports submitted to the Monitoring Team Auditor.

















4. Introduction

The environmental problem that the LIFE RE-WEEE project addresses is the environmental burden caused by WEEE. This problem is further aggravated due to the continued growth of the market and the shortening of the life cycle of electrical and electronic equipment (EEE), resulting in the accelerated replacement of equipment, making WEEE one of the fastest growing waste streams in the European market. It is estimated that about 65% of the EEE currently on the European market is separated from other household waste, but over one half of such quantity probably undergoes improper treatment and is exported illegally. The result is the loss of valuable resources and the degradation of the environment. According to CWIT (Countering WEEE Illegal Trade summary report, 2015), it is estimated that in 2012 in Europe only 1/3 of all the EEE discarded, ended up in the authorized collective systems. The other went to unknown recipients or, even if separated from the rest of the household waste, underwent improper treatment or were exported to third countries, often illegally.

During 2012-2015, about four to ten appliances were collected and recycled on average per year in Greece. This figure, although still low, is slightly compared to the rest of Europe. In particular, EEE quantities managed by "Appliances Recycling S.A." ranged between 37.000 tons in 2012 and 48.500 tons in 2015. In those years, the quantities placed on the market ranged between 110.000 tons in 2012 and 115.000 in 2015.

EEE components contain hazardous substances, such as heavy metals (Hg, Cd, Pb, Cr), polybromobiphenyls (PBB) and polybromodiphenylethers (PBDE), causing serious risks to the environment and human health, when such wastes are disposed without first being depolluted or if not properly treated. However, even when WEEE is collected separately and recycled, hazardous substances pose a potential risk to health or the environment in case are not treated using the Best Available Techniques (BAT).

The project LIFE RE-WEEE aims to reduce WEEE through the implementation of prevention of WEEE production and preparing for re-use actions, the development and demonstration of efficient sorting and preparing for re-use processes for a variety of WEEE, leading to an increased acceptance of used Electrical and Electronic Equipment (UEEE) by the consumer.

To achieve the abovementioned objectives of the project, the development and demonstrative operation of two WEEE Sorting Centres will take place in the region of Attica and Central Macedonia respectively. The operation of the SCs will be based on the specifications and technical requirements based on Best Available Techniques (BAT) for the entire "preparing for re-use" cycle that will be developed within the project implementation. The development of a measurement tool preparing for re-use and re-use activities of the project will facilitate the assessment of the level of WEEE re-use in Greece, before and after the project intervention. Finally, public awareness on the preferences for re-use rather than recycling, addressed to consumers and other stakeholders, and promotion of multiaspect WEEE prevention culture are among the expected results of the project implementation.

The objectives and actions of the project clearly falls in the topic of waste, assisting the achievement of the overall goals of the Roadmap for a Resource-Efficient Europe, the 7th EAP for 2020 and circular economy principles, namely to reduce waste and maximize re-use. The preparing for re-use and the re-use of WEEE, which are exactly the project's subject, are specifically defined as priorities in the relevant Programme Waste Topic.

The expected longer term results of the project are referred to the reduction of the produced WEEE through prevention and preparing for re-use activities, firstly at the regions of interests (Attica and Central Macedonia). The projects aims to disseminate the know-how that will be gained after the demonstrative operation of the two (2) SCs, in order other SCs to be developed in the wide area of Greece. This results long term to the reduction of raw materials and energy















consumption needed for the production for new EEE and, finally, to the limitation of greenhouse gases (CO₂) raised by the EEE production and WEEE treatment procedures.

Moreover, the project aims to develop a completed legislative framework for SCs operation in Greece. An environmental authorization framework has already embodied to the national legislation through actions of the project beneficiaries and efforts are made in order the spatial framework for SCs operation to be simplified for the future operation of relative facilities. The specifications and the technical requirements, developed for the project scope, are expected to be adopted by the relevant regulatory body (HRA), to facilitate permitting and assure quality of used EEE and prepare recommendations for policy measures, at all relevant levels- retailer management, local authority, national and EU legislation.

Finally, the tool that will be developed for preparing for re-use measurement at national level, will be suggested to be transferred and implemented by RREUSE members (beneficiary of the project), in order to constitute a reference point at EU level.

5. Administrative part

The Administrative Council of the Project (ACP) is the official decision-making body of LIFE RE-WEEE Project, consists of one representative of each beneficiary. The role of the ACP is to monitor the delivery time of the reports, according to the GA, the organization of meetings, conferences and dissemination activities, the development of the reports to EC, guidance and monitoring of financial statement reports, according to EC guidelines, and the assessment of project progress by each action implementation. The Project Coordinator constitutes the link between the ACP and European Commission. The ACP members are referred to the GA. During the kick-off-meeting, the ACP recommendation was revised according to the Diagram 1 Project Organization Chart, and 3 supporting groups of the ACP were also recommended: Project Management Group, Quality Assurance and Quality Control Group and Carbon Footprint Group.

The meetings of the three supporting groups are not regular, but are convened when necessary for the smooth progress of the project, while individual meetings of the involved beneficiaries take place to facilitate the implementation of the individual actions. Meetings among beneficiaries have been held during the reporting period, targeting to the continuous communication and information of partners for the progress of individual actions. In some cases, teleconference communication with RREUSE representatives took place, resulting in saving recourses of the project (travel and subsistence costs) and reduction of Project Carbon Footprint. Moreover, a "cloud" folder (dropbox) accessible by all beneficiaries has been created by the Coordinator for dissemination and exchanging of data (literature, deliverables, monthly reports, templates documents etc.).

The first two Monitoring Team visits were held on 23/5/2016 and 15/5/2017 respectively at the "Appliances Recycling S.A." offices. Representatives of all beneficiaries participated in the meetings (Annex 10.2.120 E.1 Participant list of 1st Monitoring Team Audit and Annex 10.2.122 E.1 Participant list of 2nd Monitoring Team Audit). The issues raised by the Monitoring Team visits were delivered to Coordinating beneficiary "Appliances Recycling S.A." as Annexes of the EASME letters by the date of 11/7/2016 (EASME.B.3 NA/fh D(2016) 3978871) and 19/7/2017 (EASME B3/NA D(2017) 4154147) respectively. Itemized responses to the EASME letter by 11/7/2016 were submitted at the 1st **PR** of the project as Annex 7.1.1 and as Annex 10.1.1 Response to letter EASME.B.3 NA/fh D(2016) 3978871 at the present report. Whereas, the itemized responses to the EASME letter by 19/7/2017 are submitted with the present report as Annex 10.1.2 Response to letter EASME B3/NA D(2017) 4154147.















Moreover, the Monitoring Team Auditor is informed frequently for the progress of the project by the Monthly progress report.

All the corresponding deliverables and supporting documents of the present report are submitted in electronic format, according to the letter by EASME on 6/12/2016 (EASME B3/AS ARES(2016) 7353988).

Additionally, all the issues raised after the 1st Progress Report submission of the LIFE RE-WEEE project, are responded at the present report as Annex 10.1.3 Response to letter EASME B3/NA D(2017) 2546267.

Finally, as it is described analytically at the corresponding Action B.5, the project team and the Monitoring Team Auditor, Mrs. Papageorgiou, were met on 13/7/2017 at "Appliances Recycling S.A." offices, in order to face the emerged constraints, concerning the lack of proposals by Attica Municipalities for infrastructure provision for the SC operation. After Mrs Papageorgiou guidance, the coordinating beneficiary sent a letter to the Project Adviser of EASME on 25/7/2017 (Annex 10.1.4 Letter to EASME_ alternative senario_action B.5 implementation_Pr. No 11494/25-07-2017), following the unanimous decision of all cobeneficiaries, describing in detail the proposed alternative scenario (Action B.5). The implementation of the proposed scenario was successfully approved by the Project Adviser, Mrs. Anna Natasa Asik via a responding e-mail on 27/7/2017 (Annex 10.1.5 Approval by EASME of letter "Pr. No 11494/25-07-2017" email)

















6. Technical part

6.1 Technical progress, per Action

A. Preparatory actions

Action A.1: State-of-the-art review

Foreseen start date: January 2016 Actual start date: January 2016

Status: Completed

Progress

HUA was responsible for the overall implementation of Action A.1, while ECYCLE, RREUSE, ECOREC, and GF had a supportive, and crucial role collection/review of the required data, taking interviews and editing of the reports. Action A.1 had a preparatory, but basic function in the implementation of the LIFE RE-WEEE project. It concerned the production of a State-of-the-Art Report on the WEEE re-use or preparing for re-use. This report forms an information tank for the implementation of the Actions of groups B (implementation actions) and D (public awareness and dissemination of results). For instance, it has already contributed to the identification of the WEEE categories for the WEEE Sorting Centres (Action B.5, sub-action B.5.1), and it has been orally presented in two International Conferences (IHWM 2016 and ATHENS 2017, for further information please refer to Action D.7).

The Report consists of three (3) parts:

The identification of initiatives and good practices in EE-28 (Sub-action A.1.1)

The first part presents more than twenty (20) WEEE prevention and preparation for reuse activities (initiatives, practices) that have been employed in Greece and at EU level until June 2016. Depending on the data availability, the activities have been evaluated upon environmental, economic and social criteria, such as their diversion potential, the reuse percentage, the difficulty of their implementation, their impact on the citizen's behaviours, and the number of jobs created. During the investigation of the aforementioned activities, it became obvious that Greece lacks such as initiatives, indicating the necessity for the implementation of the B Actions of the LIFE REWEEE project.

The investigation of legislative facilitators and barriers, at national and EU level (Subaction A.1.2)

The second part of the State-of-the Art Report involved the investigation, evaluation and presentation of legislation facilitators and barriers at national and EU level. In order to analyse the current situation, approximately fifty (50) interviews (questionnaires) were taken and a desk study (review of more than forty (40) articles and reports) was held.

The recording of the available economic instruments, that promote the WEEE reuse and the preparation for reuse (Sub-action A.1.3)

The third part of the report, i.e. the recording of the available economic instruments, will facilitate the exploitation of the available data towards the development of more effective tools. Although various instruments are presented, special emphasis has been given on the Extended Producer Responsibility (EPR) systems, due to its high effectiveness and importance in WEEE management.

Since part of the stakeholders were the same with those in Action B.1, an integrated questionnaire of both Actions was distributed according to Project team decision. So as Action

















B.1 was in progress after the end date of Action A.1, the deadline for the completed questionnaires was set in December 2016, and therefore the state-of-the-art report is submitted revised with the **MTR**, according the received feedback.

To proceed in feedback receiving, a modified questionnaire concerning Action A.1 was delivered in countries where prevention of WEEE production and preparing for re-use are in early stage (such as in Greece and Serbia), in order to collect more credible and closer to reality information. Stakeholders that are involved scientifically in re-use issues (e.g. academics) and are well aware of the corresponding legislative issues, were asked to complete the modified questionnaire of Action A.1. The questionnaires are annexed with the **MTR** as Annexes 10.2.2 Integrated Questionnaire A1- B.1_En, 10.2.3 A.1 Questionnaire_EL and 10.2.4 A.1 Questionnaire EN.

The "State-of the-Art report" was submitted to the EC as Annex in the 1st Progress Report ("7.2.1 A.1 Del State-of-the-Art report"). However, the State-of-the-Art report is improved in line with remarks by the EC (EASME letter – Ref. Ares(2017)2235438 – 02/05/2017). Therefore, the revised deliverable is re-submitted by HUA (beneficiary in charge) and is provided with this report (Mid-term report) as Annex 10.2.1 A.1 Del State-of-the-art report_revised. The remarks of the EC involved the further analysis on Financial Instruments available for the promotion of WEEE reuse and/or preparing for reuse, and the addition of the collected responses in short tabulated form. These additions did not introduce any delay to the subsequent Actions of the project.

Delays

The draft report was delivered in June 2016, and finalised 1,5 month later than the foreseen time-plan (August 2016), but this did not introduce any further delay to the subsequent Actions of the Project, neither did it affect its smooth implementation. 98% of the State-of-the-Art Report was completed by August 2016. The delay of the rest 2% was due to the recording of national legislation of other EU member-countries, as are reported in local languages and the delay of the interview responses.

The participating beneficiaries dealt with this obstacle effectively, using an integrated approach of the subject, and modifying the questions of the interviews. In September 2017, updated data about the reported practices were available. Therefore, the LIFE RE-WEEE consortium, decided to revise the State-of-the-Art report accordingly, and add the analysis of the new interviews (questionnaires).

Action B.1: Design and develop assessment tools and methodologies

Progress

The Action is in progress and RREUSE is responsible for the action implementation and collaborated with ECOREC, ECYCLE, HUA and HRA during the initial time period. The aim of this action is to develop a comprehensive methodology and a corresponding tool for reliable and comparable assessment of the measurement of preparation for re-use of WEEE in the EU. This methodology will not only be the one used in the two sorting centres set up in regions of Attica and Central Macedonia, but also applied by at least 10% of RREUSE members. This action consists of three (3) sub-actions as described below:

Sub-action B.1.1 is referred to inventory of existing measurement methodologies of WEEE reuse and preparing for reuse. For the purpose of this inventory, three (3) questionnaires were developed, submitted as Annexes 10.2.2 Integrated Questionnaire A1- B.1_En, 10.2.6 B.1 Questionnaire for Producer Responsibility Organisations (PROs) and 10.2.7 B.1 Questionnaire for Local Authorities of the MTR, containing questions related to the amount of WEEE collected and re-used/prepared for re-use and the way it was calculated. One of the 3 questionnaires constitutes integrated version with Action A.1, as decided by the Project team, due to common part of stakeholders that the questionnaire was addressed to. The questionnaires were sent to different stakeholders working on re-use/preparing for re-use activities. The questionnaires were revised a few times to try both to simplify it and get more data from the respondents based on relevant feedback. The report had a delay of 3 months, till June 2017, for the completion of this deliverable, and last clarifications on the questionnaires resulted in revisions till September 2017. However, this final delay did not strongly affect to the overall project implementation. Once the data from the questionnaires were recorded, the processing and analysis of the collected data started on June 2017.

The collection of the answers resulted in the creation of 3 Excel Spreadsheets which can be considered as supporting documents of the **MTR**:

- B1.1_Answers received: In this spreadsheet all the 31 answers received are displayed representing a total of 351 different actors.
- B1.1_Comparison study: In this spreadsheet, all the calculation methods are analysed according to their similarities and differences: 27 different calculation methods
- B1.1_Results of the answers: Shows what the results would look like if the same data collection method as the Flemish association Komosie were to be used.

















An abstract of the results of these tables has been uploaded on the LIFE RE-WEEE website and annexed as 10.2.5 B.1 Del Inventory of existing calculation methods of reuse and preparation for re-use of WEEE. This abstract will be considered as the deliverable for the public since the tables contain confidential information.

31 questionnaires were collected from reuse networks and centers representing more than 339 re-use and preparing for re-use centres since a lot of "umbrella" organisations answered on behalf of their members. In total, 351 reuse centers and other relevant actors were represented in the responses vis a vis the 200 envisaged.

Sub-action B.1.2 is the reporting of a comparative analysis of existing measures used in the EU. The content of this report is based on actual data that were collected through the questionnaires in the framework of sub-action B.1.1 titled as "Mapping of the Currently Applied Methodologies for Re-use and Preparing for Re-use of WEEE". The collected data will be processed in order to set the baseline for a comparative evaluation of the respective methodologies by means of identifying common procedures as well as differences. The results of the comparative evaluation will highlight the best available and applied techniques for practicing and assessing re-use of WEEE and, at a later phase, form the guidelines for developing an integrated methodology for WEEE re-use and preparing for re-use as part of the Deliverable B1.3 titled "Integrated Methodology".

The comparative analysis report was foreseen to be delivered on September 2017. There was a delay of the report delivery because of the late achievement of the action B.1.1. However, the completion of this sub-action (B.1.2) started before the end of the action B.1.1 and is already well advanced. The proposed comparative evaluation of the applied (W)EEE re-use methodologies based on the utilization of the "Likert Scale" technique. This technique is widely applied for the extraction of comparative results that are derived from both quantitative and qualitative parameters. The parameters and features have been extracted from the methodologies and the quantifiable weighting factors and levels of preference are in discussion (until the end of November) both between the project partners and the RREUSE WEEE working group. The corresponded deliverable of sub-action B.1.2 is in draft version, available upon request, and will be finally delivered in January 2018.

Sub-action B.1.3 referred to the development of the integrated methodology for re-use and preparing for re-use of WEEE measurement does not fall in the reporting period of the MTR.

Delays

As described above, some delays were faced in the action B.1.1 which are resulting in delays for action B.1.2. RREUSE and the partners had to send several reminders and take advantage of some events which occurred after the foreseen date to get some more answers (like for e.g. the annual meeting of WEEE-Fora). The amount of data asked from the respondents was also quite detailed and probably discouraged potential respondents to fill in the questionnaires. The delay was also linked to a late additional clarification to the questionnaire in the categories of waste collected and re-used in April 2017. RREUSE had to wait for former respondents to answer to this additional question.

An online Google Form was created to try to facilitate the collection of data, but it ended up being not very effective. The sending of reminders was proven to be the most effective way to collect new answers.

This Action is ongoing and progresses according to the foreseen timetable. GF is responsible for the overall coordination and implementation of this action, with the contribution of all beneficiaries based in Greece. Five (5) Consultation Fora (2 Thematic Consultation Fora (TCF) and 3 Open Consultation Fora (OCF)) have been implemented until the submission of the MTR.

More specifically:

The 1st TCF was organized at Harokopio University facilities on 14/06/2016, in the context of sub-action B.6.1. The main topic of discussion involved technical issues on the development of the EEE exchange/donation platform. Therefore, representatives of all project beneficiaries, the IT team of Harokopio University, experts topics related to WEEE preparing for reuse and actual reuse of EEE and representatives of Social Economy areas (providing examples on good EEE reuse practices through teleconference), participated in the Fora. The relevant minutes are submitted as Annex 10.2.9 B.2 Minutes of 1st Thematic Consultation Fora and are also included in Annex 10.2.8 B.2 Del 1st Annual report on the Consultation Fora of the MTR.

The 1st OCF was held on 20/07/2016 at GF facilities. Before the Fora implementation, an informative letter (submitted as Annex 10.2.10 B.2 Municipalities informative letter) concerning LIFE RE-WEEE short description and information about the 1st OCF organization, was delivered to all Municipalities of the 2 regions of interest (Attica and Central Macedonia). The Fora topics covered general information on the LIFE RE-WEEE project and information regarding the future launch of the call of interest for the selection of the Municipalities where















the first two (2) WEEE Sorting Centers will operate. More than 90 stakeholders from 48 different organizations participated in this Fora. The relevant minutes are submitted as Annex 10.2.11 B.2 Minutes of 1st Open Consultation Fora and are also included in Annex 10.2.8 B.2 Del 1st Annual report on the Consultation Fora of the **MTR**.

The 2nd OCF was held on 22/09/2016 in Nea Triglia Chalcidice. 113 stakeholders from 58 different organizations participated in this Fora. The topics of the Fora were related to information regarding the future launch of the call of interest for the selection of the Municipalities where the SCs will operate, were presented to the Municipalities of Central Macedonia region. The relevant minutes regarding this Fora are submitted as Annex 10.2.12 B.2 Minutes of 2nd Open Consultation Fora and are also included Annex 10.2.8 B.2 Del 1st Annual report on the Consultation Fora of the **MTR**.

The 3rd OCF was held on 10/03/2017 at GF facilities. 87 stakeholders from 44 different organizations participated this Fora. The aim of the Fora was the detailed presentation of the tender procedure for the selection of the Municipalities that the SCs will be hosted. Mrs Banti, EU DG ENV Policy Officer – WEEE also participated in the event by presenting the European Policy principles concerning WEEE treatment and Circular Economy. The relevant minutes regarding this Fora are submitted as Annex 10.2.13 B.2 Minutes of 3rd Open Consultation Fora of the **MTR**.

The 2nd TCF was held on 14/07/2017 at Harokopio University facilities in the context of subaction B.6.1, with the goal to present the EEE exchange/donation platform (purpose and operation) to non-profit organizations and organizations with an active role in social economy (Sub-action B6.1). Nineteen (19) stakeholders corresponding to eight (8) public and private bodies participated in this Fora. The relevant minutes are submitted as Annex 10.2.14 B.2 Minutes of 2nd Thematic Consultation Fora of the **MTR**.

Action B.3 is in progress according to the foreseen timetable. HUA is responsible for this Action implementation. Up to September 2017, the LIFE RE-WEEE consortium was tasked with the preparative and data collection activities, which will facilitate the smooth development and completion of Sub-actions B.3.1 and B.3.2.

More specifically, the following activities were conducted:

- Available databases regarding EEE reuse and WEEE preparing for reuse in Greece are being investigated. A desk-study for the data sources relevant to the WEEE amounts in relation to the economic crisis in Greece, has started.
- A contact database was developed. The database contains contact information about stakeholders of the EEE reuse and WEEE preparing for reuse sector, which could provide data for the elaboration of the reports (Deliverables of March 2018 and June 2018). The majority of the listed stakeholders are affiliated partners of ECYCLE. ECOREC has expanded the database with organisations developing social initiatives.
- A questionnaire (please refer to Annex 10.2.15 B.3 Questionnaire) was developed to facilitate the collection of reliable data from stakeholders (listed in the aforementioned database). More specifically, in June 2017, EC (contact persons: Maria Banti and Jiannis Kougoulis) brought the LIFE RE-WEEE project in primary contact with Deloitte (contact person: Andreas Mitsios) to investigate the potential of a synergy regarding the collection of data in Greece, as Deloitte also conducts a (wider) research on reparability. This contact resulted in the development of an integrated questionnaire, which facilitates both studies.
- Up to September 2017, the questionnaire was sent (through e-mail/fax) to over 150 affiliated partners of ECYCLE. HUA, ECYCLE and GF collected and analysed the filled-in questionnaires. The questionnaires will be distributed to all stakeholders of the developed database, by the end of December 2017.

Action B.4: Development of specifications and technical requirements for the entire "preparing for reuse" cycle

Progress

Action B.4 is in progress within the foreseen timetable. HRA is responsible for this Action implementation, with the contribution of ECYCLE, RREUSE, ECOREC and HUA. Action B.4 is divided in three sub-actions, with only sub-action B.4.1 to fall under the reporting period. A research for data collection was conducted in order the 1st issue of specifications and technical requirements for collection, transfer, sorting and storage of WEEE to be drafted (Annex 10.2.16 B.4 Del 1st issue of specifications and technical requirements for collection, transfer, sorting and storage of WEEE). The specifications development was based on European standards (CEN-CENELEC as the main document and WEEE Labex as a supplementary document) along with current Best Available Techniques (BAT) and developed specifications in other European countries (PAS, OVAM, Wrap). HRA proceeded in the corresponding standards purchase, in order to collect information for the development of the 1st issue of requirements. For the specifications drafting, Project Team took into account the parameters of Greek situation, since for the first time requirements concerning preparing for re-use procedures are being developed. In addition, the second deliverable concerning the process relating to the preparing for the reuse of WEEE (Annex 10.2.17 B.4 Del General Issue of specifications of preparing for re-use stage of WEEE) was prepared taking into consideration the European Standard CEN-CENELEC and data already collected in the previous stage (developed specifications in other European countries, developed or under submission European standards, Best Available Techniques) as well as the material prepared in the former deliverable (Annex 9.2.16 B.4 Del 1st issue of specifications and technical requirements for collection, transfer, sorting and storage of WEEE). The aim was to develop the framework concerning the technical requirements for the preparing for re-use process, taking also into account the European and Greek legislation. Furthermore, the preparation of the five (5) specific issues of specifications of preparing for re-















use stage for all WEEE categories (except lamps) is in progress and a draft version is available upon request.

HRA cooperated closely with ECYCLE, taking into consideration the recommendations of the rest of the partners. This includes many meetings that took place between HRA and ECYCLE, as well as round table discussions and skype meetings with all the partners.

Since RREUSE experience in preparing for re-use procedures is very important, an executive summary of under-development requirements was prepared by HRA, in order RREUSE to could contribute in the deliverable preparation.

A problem addressed was the translation and performance in Greek of English terminology, so that to not overlap or being confused with the existing Greek legislation terminology. This problem was solved upon discussions among the partners by consulting current National Legislation. Furthermore, another problem occurred was the end of the cooperation with the former additional staff who was part of the project team and seriously involved in the preparation of the deliverables. The situation caused the delay in delivery of the following deliverable "5 specific issues of specifications of preparing for re-use stage for all WEEE categories (except lamps)". The problem was resolved by concluding a contract with a new external assistant, following the relevant administrative and legal procedures of HRA.

Delays

The required administrative and legal procedures of HRA in order to replace the external assistance caused the delay in delivery of the deliverable "5 specific issues of specifications of preparing for re-use stage for all WEEE categories (except lamps)". The preparation of the issues is in progress and is expected to be completed within the next two months. The delay is not expected to affect the proper implementation of the project, as the specific issues are going to be completed with only a short delay and will be available in order to be used in Action B.5 during the implementation of Sorting Centers.

Action B.5: Design, development and operation of WEEE Sorting Centers

Foreseen start date: April 2016 Actual start date: March 2016

Status: In progress

Progress

ECYCLE is responsible for this Action implementation and all partners contribute to the progress. Action B.5 is divided into 6 sub-actions:

Sub-action B.5.1 is referred to the development of the SCs Management Plan, started on March 2016 by collecting information firstly about authorization and spatial planning issues of facilities such as WEEE sorting center. This research also included the definition of the following topics, according to the approved proposal:

- SCs capacity
- Workplaces requirements
- WEEE categories that the SCs will manage
- Resources of income WEEE to the SCs
- Proper activities for the SCs operation
- Specifications of the WEEE collection bins (containers)

In detail, HRA and ECYCLE proceeded in the determination of spatial specifications within the period time of March – July 2016, in order to be presented at the 1st Open Consultation Fora (see Action B.2). The Project Team faced legislative constraints concerning the SCs authorization. The current National legislation puts restrictions in the settlement of waste management facilities (collection, sorting, storage, treatment, disposal etc.), such as SC, outside the districts of the defined Urban Plan, according to PD 31/1985, or inside industrial areas according to PD 166 D/1987. In the context of the development of spatial planning framework of Green Recycling Centers, communications between HRA, as representative of the LIFE RE-WEEE Project, and the General Secretariat for Regional Planning and Urban Development of Ministry of Environment and Energy ("YPEN") took place, in order the SCs to be allowed settled down within the Urban Plan's districts, combined with Green Recycling Centers or in adjacent sites (the proposal for SCs spatial framework is submitted as Annex 10.2.26 B.5 Proposal for SCs spatial framework – e-mail). Due to the additional activities that take place in SCs (e.g. storage), the SCs operation could not be included in a common spatial framework with the Green Recycling Centers. Therefore, ACG decided to proceed according to the current Legislation restrictions, in order to accelerate the procedure for SCs development. However, the Project Team continues to make efforts for the spatial planning framework of SCs under cooperation with the General Secretariat for Regional Planning and Urban Development of YPEN, to facilitate the development of more SCs, out of the Project frame, in the wide region of Greece.

Moreover, environmental authorization restrictions set by the National Legislation were not fixed by the start of the project. The Project Team, represented by HRA, proceeded in amendment proposal of the M.D. 1958/2012 concerning authorization issues of SCs, in order to be included in the current legislative framework. HRA is supervised by YPEN. With the cooperation of the Department of Recycling and Alternative Management of YPEN, through oral communications mainly, issued modifications for the M.D. 1958/2012 to the Department of environmental authorization of YPEN. The final proposal (Annex 10.2.27 B.5 Final proposal















for MD 1958/2012 modification – e-mail) was sent on 1/6/2016. According to M.D. 1958/2012 amendment, which entered into force on 10/8/2016 by M.D. 37674/2016 (ΦΕΚ 2471/B/10-8-2016) (Annex 10.2.28 M.D. 37674/2016 (ΦΕΚ 2471/Β/10-8-2016) Σφάλμα! Το αργείο προέλευσης της αναφοράς δεν βρέθηκε.), SCs included in the Group 4 "Environmental Infrastructure Systems" as "Sorting Centers of Electrical and Electronic Equipment (WEEE) -Including facilities for preparing for reuse of WEEE (category "9y").

Sub-action B.5.2 includes the conduction of the call of interest for the Municipalities selection that the two (2) SCs will operate and the tender procedure for the contractors' selection that will manage and operate the two (2) SCs as well.

Before the call of interest launch by the GF, the project team faced barriers concerning the definition of the required specification of the SCs infrastructures. Within the implementation of the 1st Consultation Fora (20/7/2016), the Project Team addressed constrains by Municipalities side that participated in the Fora (Action B.2), concerning the availability of infrastructures of suitable properties that are in compliance with the current Legislation and meet the defined specifications, in order to take part at the tender procedure. Although seven (7) Municipalities had declared interest by sending supporting letters at the submission phase of the proposal (submitted at the "Attachments" of the LIFE RE-WEEE proposal), the Political Will to approve the participation of the Municipalities to the call of interest and commitment for the infrastructure providing was a very lengthy procedure. As it was described at the Action B.2, Municipalities of the Attica and Central Macedonia region were firstly informed for the LIFE RE-WEEE Project by an informative letter (Annex 10.2.10 B.2 Municipalities informative letter). Afterwards, visits to Municipalities of Attica and Central Macedonia (Annex 10.2.29 B.5 Municipalities visits) that have already declared interest for the SCs' settlement within their boundaries, took place by representatives of all Beneficiaries, for detailed information regarding the spatial planning required specifications within the period time of July – November 2016. Visits of contingent available properties took place as well, in order ECYCLE to proceed in modifications of the SCs technical specifications according to Greek conditions. Informative technical material was sent to Municipalities when it was required, before the visits. An evaluation document was developed in parallel for the recording of available properties and the Municipalities declaration of interest, in order to facilitate in current situation assessment and the proposal of alternative solutions by the ACG. At the same time, the Project team proceed in extensive market research through brokers, to facilitate the definition of SCs' facilities technical specifications. The ACG suggested as alternative solutions the providing of leasing infrastructures by an individual or partnership of Municipalities. Moreover, ACG made efforts in order the regions of Attica and Central Macedonia and "EDSNA" (" $E\Delta\Sigma NA$ "), association of solid waste management of Attica, to contribute to SCs operation and support LIFE RE-WEEE project (Annex 10.2.30 B.5 List of meetings and correspondence with Regional Authority representatives).

The QA/QC Group, based on the draft Management Plan (at the topics as mentioned above), defined the SCs' technical specifications of the informative issue, in order to be included at the call of interest issue by the GF. SCs technical specifications were based to a significant extent to existing industrial buildings specifications, as these are defined by the National building and planning legislation and after the extensive market research through brokers, as well, by the Project team.

Afterwards, an ACP meeting was held to define the final evaluation criteria for the assessment of the available areas that comply with the current legislation restrictions. During this meeting, an Advisory Scientific Committee (ASC) was recommended by representatives of each beneficiary, except the GF. This Committee role was to support, if necessary, the Evaluation Committee of GF concerning technical issues for the SCs siting and operation, in the case it is















decided by the Green Fund internal procedures. The final informative issue of SCs technical specifications (Annex 10.2.24 B.5 Issue of infrastructure and operation technical requirements of SCs), was submitted to the GF Board of Directors (BoD) on 12/12/2016, followed by the proposed evaluation mechanism system (Annex 10.2.25 B.5 Evaluation mechanism system), through a "rapporteur letter" by ASC. GF BoD approved the proposed informative issue and evaluation criteria, following the internal procedure of GF and the call of interest announcement took place on 20/2/2017, after publication at the websites of GF, YPEN and LIFE RE-WEEE (Annex 10.2.18 B.5 Del Call of Interest by GF (including the Annexes of the call) and Annex 10.2.19 B.5 Del GF BoD Decision for the call announcement). The Evaluation Committee of GF assumed full responsibility for the final form of the informative issue. The deadline for the proposals submission was firstly set on 10/4/2017.

After the tender announcement, the 3rd Open Consultation Fora (Action B.2) was held on 10/3/2017. All the Municipalities of the two regions were invited in order to be informed in detail regarding their participation in the call of interest.

Due to the fact that there was no proposal submission till 5/4/2017 and after official requests to the GF for tender prolongation by 3 Municipalities, (consortium of Kifissia-Dionysus, Piraeus, and Thessaloniki), the BoD of GF decided on 7/4/2017 and announced on 10/4/2017 a tender prolongation for a period of one (1) month (Annex 10.2.20 B.5 Del GF BoD decision for tender prolongation). The new deadline of the proposal submission was set on 10/5/2017.

By the end of the 1st phase tender deadline, five (5) Municipalities and one (1) consortium of Municipalities submitted their proposals, as listed below:

Attica region:

✓ Consortium of Kifissia – Dionysus

Central Macedonia region:

- ✓ Ampelokipoi Menemeni
- ✓ Oraiokastro
- ✓ Pella
- ✓ Thessaloniki
- ✓ Volvi

The evaluation procedure of the 1st phase for the submitted proposals completed by the Evaluation Committee on 30/5/2017 (Annex 10.2.21 B.5 Del 1st Evaluation Phase results by GF Evaluation Committee) and the results were published at the websites of GF and LIFE RE-WEEE project. All the above listed Municipalities, except Volvi, met the required criteria of the 1st phase of the tender and were invited to submit the corresponding justifications of the 2nd phase according to the Call of Interest. The 2nd evaluation report by the Evaluation Committee of the GF was announced on 12/07/2017 (Annex 10.2.22 B.5 Del 2nd Evaluation Phase results by GF Evaluation Committee). More details regarding the technical reports submitted by the Municipalities during the 2nd phase of the tender procedure have been asked to be submitted till 21/7/2017. The final results of the evaluation procedure were announced by the GF on 31/7/2017 (Annex 10.2.23 B.5 Del Evaluation Phase final results by GF BoD) and were available on the GF and LIFE RE-WEEE websites. The 1st WEEE SC will operate in the Municipality of Oraiokastro for the case of the Central Macedonia region garnering the highest rating within the evaluation procedure.

The tender procedure ended with no result for the case of the Attica region. To address the emerged constraint, the project team, after the guidance of the Monitoring Team Auditor, Mrs. Papageorgiou, at the meeting of 13/7/2017, sent a letter to the Project Adviser of EASME on 25/7/2017 with Protocol No 11494 (Annex 10.1.4 Letter to EASME_ alternative senario_action B.5 implementation_Pr. No 11494/25-07-2017), detailed a proposed alternative scenario as followed: An integrated tender procedure for the operation of the SC in the Attica region

















through the selection of a combined contractor – infrastructure scheme, conducted by "Appliances Recycling S.A.". The implementation of the proposed scenario was successfully approved by the Project Adviser, Mrs. Anna Natasa Asik, on 27/7/2017 (Annex 10.1.5 Approval by EASME of letter "Pr. No 11494/25-07-2017" email). The project team started to work on the development of separate informative issues for the two tenders for contractors' selection (one for each region of interest), in order to be conducted in parallel.

The tenders for the contractors' selection for the SCs operation will be announced in November 2017 by "Appliances Recycling S.A." and will be available on the websites of ECYCLE and LIFE RE-WEEE. The tenders will be conducted according to the internal regulations of the Coordinator (Procurement Regulation of "Appliances Recycling S.A.") and in compliance with the LIFE programme Common Provisions and National legislation. The duration for the proposals submission will be set for one (1) month and afterwards, the evaluation procedure will be implemented within December 2017. The three-member Evaluation Committee (Technical and Financial Committee) of "Appliances Recycling S.A.", consisted by the Managing Director, the Financial Manager and the Technical/Environmental Manager of the company will proceed in the evaluation procedure of the candidate contractors, according to the evaluation mechanism developed by "Appliances Recycling S.A.". The Evaluation Committee will award the contract to the tender offering best value for money. For the project's needs, an Advisory Scientific Committee (ASC) will be recommended by representatives of each beneficiary. The ASC role is to support, if necessary, the Evaluation Committee of "Appliances Recycling S.A.", concerning technical issues for contractors' selection. The two SCs will be fully operated in March 2017. The construction correction activities that the infrastructures of the Municipality of Oraiokastro for the operation of the SC need, are not crucial and will not delay the beginning of the SC operation.

The initial agreement regarding the procurement of equipment and consumables by the GF, based on the GA, has already been signed between the Municipality of Oraiokastro and the GF in September 2017. The project's ASC will determine and recommend to the GF the equipment and consumables needed for the operation of the Oraiokastro WEEE SC, after the selection of the contractors, in order to assess the deficiencies of the infrastructures and to cover the needs for the proper operation of the SC. The initial agreement between GF and the Municipality of Oraiokastro will be then revised and re-signed by the two parties, in order to initiate the procurement process. Approximately 2.5 months from the initiation of the process are needed for the procurement of the relevant consumables and equipment by the GF.

Sub-action B.5.3 concerns the installation and operation of SCs according to the defined specification and requirements. This sub-action does not fall within the reporting period.

In the context of **sub-action B.5.4**, educational activities to SCs will take place for the proper management practices concerning WEEE preparing for re-use procedures. This sub-action includes the preparation of handbooks for good practices of WEEE management. These handbooks were expected on 9/2017. However, the handbooks are still under development, since the conduction of the open tenders for the contractors' selection is ongoing. It is estimated that the handbooks will be delivered by the end of November.

Finally, **Sub-actions B.5.5 and B.5.6** that will be implemented after the SCs operation, concern public and stakeholder information regarding the operation of the SCs and relative issues to WEEE prevention and proper WEEE management procedures.

Delays

The launched of call of interest for the Municipalities selection concerning SCs siting deviates from the scheduled timetable by 5 months. This deviation is due to the Legislative restrictions or lack of legislative framework regarding SCs authorizations issues. These parameters had

















impact to the available properties of Municipalities, in order to be in compliance to National Legislation. Moreover, the responding time by the Municipalities in order to declare their interest concerning their participation in the LIFE RE-WEEE project and the call of interest by GF depended on the level of their Political Will and this for the majority takes long time. Moreover, due to the National Legislation restrictions, determination of the evaluation criteria and SCs spatial specifications were also delayed. According to internal procedures of GF, a period time of 2 months was required for the approval of the evaluation mechanism system, proposed by ASC.

Moreover, due to lack of submitted proposals during the tender procedure, BoD of GF decided to prolong the tender deadline for one (1) month, taking into account the official requests for tender prolongation by some Municipalities of interest.

The fact that the Municipalities' tender had no results for the case of Attica region, led the Project team to find an alternative scenario for the operation of the SC in Attica and request the approval by the Project Adviser of EASME.

The above deviation by the foreseen timetable, resulted in seven (7) months delay of the announcement of the tender procedure for the contractors' selection. This delay is not expected to affect the proper implementation of the project, neither the SCs operation, since the two SCs will be fully operated in March 2017. The qualitative and quantitative objectives of the GA are not affected, since "Appliances Recycling S.A." ensures the transport of the targeted quantity of WEEE (1.500tn/year of WEEE) to the two SCs, through the company's affiliated network. Moreover, the faced barriers led the project team to overcome the relevant constraints and pave the way for the settlement and operation of facilities relevant to sorting centers for WEEE, and all the waste streams as well.

Action B.6: Promotion and support of the WEEE prevention culture in Greece

Foreseen start date: April 2016 **Actual start date:** March 2016

Progress

Action B.6 is in progress as foreseen to the timetable. ECOREC is responsible for the overall Action implementation, with the contribution of all partners. Action B.6 is divided to two (2) sub-actions:

Sub-action B.6.1: design and development of a collaborative web-based platform for EEE donation and exchange

This Sub-action was set to be advanced by HUA in two stages, corresponding respectively to Activities B.6.1.1 and B.6.1.2. The first stage, which concerned the design and development of the LIFE RE-WEEE platform was completed, while the second started in April 2017 and is still in progress as anticipated.

The first step for the implementation of B.6.1.1 was the requirements and design analysis of the collaborative web-based platform, which consisted a milestone of the Project (Annex 10.2.36 B.6 Mil Analysis of platform requirements). The milestone was achieved in June 2016, as anticipated. In order to define the requirements of the collaborative platform, the consortium of the Department of IT and Telematics (HUA) investigated the existing platforms for goods/service exchange and donation, and contacted the coordinators of the project partners, the members of the management teams of LIFE RE-WEEE and experts on EEE and WEEE. Last, but not least, the consortium suggested a Thematic Consultation For aregarding platforms, in the framework of Action B.2, which took place at 14/6/2016 (Annex 10.2.9 B.2 Minutes of 1st Thematic Consultation For ain Action B.2). A report with the outcomes of the analysis was delivered to the coordinator in the end of June 2016.

In short the aforementioned requirement analysis report presents:

- The aim of the platform, and its use on an individual or society level,
- The methodology that will be used in order to enhance and implement the concept of exchange and donation,
- Description of the user interface, and the platform-user interaction,
- Basic user requirements, and
- The platform's functionality (i.e. the services that are to be provided to users, a userrole categorization and the available categories of EEE).

















After the completion of the requirements analysis, HUA was tasked with the development of the platform architecture, which consisted of two distinctive parts: 1) the main web platform with which the external users will interact, and 2) an administrator console accessible solely to the platform's administrator(s). Both parts are designed and developed with Python language standards through the use of the Django framework.

The pilot collaborative platform was delivered in April 2017, which is a month later than anticipated. This delay was due to the inclusion of an extra feature that will facilitate the statistic analysis of the collected data. In specific, a "background" codification of the registered and exchanged EEE (i.e. invisible to the users), was created. The codification is based on the 6 new WEEE categories of the EU Directive 2012/19/EU and the UNU-codes, which are the most common methods of WEEE designation, and will facilitate the extraction of a detailed report on the EEE exchange activity of the platform. This short delay did not have a negative impact on the LIFE REWEEE project implementation. Within the proposal, the platform was intended to be developed only in Greek, the project consortium decided to develop it in English too.

Activity B.6.1.2 started in April 2017, following the development of the platform, and it is in progress as anticipated. It concerns the pilot implementation, testing and improvement of the platform. Within the framework of this activity, the project consortium suggested the organisation of a Thematic Fora, aiming at the presentation of the platform to non-profit organisations and/or organisations with active role in social economy. The meeting was organised on 14 July 2017 (Annex 10.2.14 B.2 Minutes of 2nd Thematic Consultation Fora in Action B.2). The feedback of the participants is being "embodied" to the platform. Therefore, the final version of the platform will be completed and delivered a month later, in November 2017. This delay has no impact on the project implementation. At this point, it is worth mentioning that the platform is anticipated to be revised 6 and 9 months after its completion (please refer to the Indicators of progress, Technical Part).

Sub-action B.6.2: Implementation of six "Learn to Repair Events"

The first repair event is scheduled for December 2017. However, several actions have been taken within the context of this sub-action. Namely, in June 2016, a meeting with RREUSE and ECOREC was held with the "REPAIR CAFÉ" foundation's president and Director to discuss synergies between the events to be held in Greece and Repair Cafés' model, as well as the tools available in Greek to attract a wider use. As well, several discussions were held with the "ANAKYKA $\Omega\Sigma$ H Σ THN Π H Γ H" ("Recycling at Source"), a social enterprise from Patra that has implemented the first Repair Café in Greece in the last year. The project has collected initial data from these events to see what type of EEE were the ones most brought to the events. Furthermore, contact was also made with the "Restart Project" which promotes "pop-up parties" for electronics repair events. Parameters were used to narrow down the repairs that would be presented in the Quick Repair Guide. Selection is based on 1) common repair needed 2) safe repair for a layman to conduct 3) repairable with standard household toolkit (i.e. No specialized tools or spare parts needed). The IT section of the guide focused on repairs related to PC, laptop, screen, portable hard drive, Tablet – Smartphone, power cable, remote control, earphones and router.

Delays

The final version of the platform will be completed and delivered a month later than anticipated (i.e. November 2017), as to be improved upon the remarks of social – active and non – profit organisations. This delay will have no negative impact on the project implementation.

The Quick Repair Guide deliverable has been delayed. Although the repairs regarding IT equipment were collected, recorded and written, there has been difficulties completing the sections regarding common, repairable, do it yourself (DIY) repairs of small household

















electrical equipment. The primary reason is that the electricians contacted are fearful that by providing this information it will lose them business, although in cases where this has happened abroad it has increased business by having consumers turn to the option of repair when it is a more difficult repair or a spare part is needed. Larger companies will not do it as this is against their service contract with manufacturers. If this obstacle is not overcome by December 2017, we will pool the repairs from the repair cafes and the electricians hired by the project for the repair cafes will conduct the repairs for the guide. This delay does not affect any other action.

Overall, Life Cycle assessment methodologies advance in four subsequent stages: 1. Goal and scope definition, 2. Life Cycle Inventory, Life Cycle Assessment, and 4. Interpretation of results. Up to September 2017, the first stage has been completed and the 2nd stage is in progress. The definition of the parameters framework for the conduction of both S-LCA and E-LCA was completed in March 2017, as anticipated. It was delivered to the Project Monitor Mrs S. Papageorgiou during the project visit of 5th of May 2017, and is Annexed with this report (MTR) as 10.2.40 C.2 Mil Social and Environmental LCA parameters.

More specifically, throughout the reporting period of time, the following activities per Subaction have been performed:

Sub-action C.2.1: Assessment of the socio-economic impact of the project:

The framework of the parameters needed for the performance of the S-LCA, has been defined (please refer Annex 10.2.40 C.2 Mil Social and Environmental LCA parameters). The framework involves the definition/description of social impacts and the categorization of socioeconomic indices, and the definition of "target" groups (e.g. employees, consumers, local community etc.).

Sub-action C.2.2: Assessment of the environmental impact of the project:

The framework of the parameters needed for the performance of the E-LCA, has been defined (please refer Annex 10.2.40 C.2 Mil Social and Environmental LCA parameters). The Action is in progress and ECYCLE is responsible for the implementation with the contribution of all beneficiaries. Action D.6 is composed by two sub-actions.

In the context of sub-action D.6.1, the 1st Press Conference was organized by the Project team on 11/5/2016 at the Ceremony Hall of Harokopio University of Athens (Annex 10.2.51 D.6 Photos of 1st Press Conference). Journalists from newspapers and "skai TV" channel joined the event (Annex 10.2.52 D.6 Journalists' participant list). The 1st press release (Annex 10.2.53 D.6 1st press release) was delivered and published in Mass Media, and a short presentation of LIFE RE-WEEE Project was presented at the TV show "econews" on skai TV channel. Moreover, Prof. Lasaridi, representative of HUA, gave an interview at the National TV channel in the TV show "ON EPT", introducing the benefits of prevention of WEEE production and reuse. An article describing the main objectives of LIFE RE-WEEE project was published at a weekly newspaper "KEΦAΛAIO". The informative website "green agenda" published an article concerning the operation of the two SCs at the regions of Attica and Central Macedonia respectively. The 2nd press release (Annex 10.2.60 D.6 2nd press release) was published concerning the implementation of the 3rd Open Consultation Fora (OCF). LIFE communication

















team received the press release concerning the 3rd OCF on 25/4/2017. All the above publications were presented as Annex 10.2.50 D.6 Del Publications in Mass Media - Interviews, including publications within the reporting period. A radio show "ERT IDEODROMIO" covered in one hour episode both LIFE RE-WEEE & DEBAG with representatives of ECOREC on 29/7/2017. Sub-action D.6.2 includes, among others, the development and printing of LIFE RE-WEEE leaflets (18,000 Greek and 6,000 English leaflets, according to GA). The Project team decided to proceed in printing of 6,000 Greek and 3,000 English leaflets, concerning a general description of the Project in both languages (9,000 leaflets in total). Since the beginning of SCs operation, a new more technical leaflet will be developed and printed. The 1st version of the Project leaflet (Annex 10.2.54 D.6 Del project informative leaflet_EL and Annex 10.2.55 D.6 Del project informative leaflet_En) was developed in May 2017 and is delivered during the events organized by the project team and to conferences or events/exhibitions that the project team participate in (e.g. BREAKFREEE Greece campaign, 82nd Thessaloniki International Fair)

The 1st newsletter (Annex 10.2.56 D.6 Del 1st Newsletter LIFE RE-WEEE _EL and Annex 10.2.57 D.6 Del 1st Newsletter LIFE RE-WEEE _En) was released via e-mail in January 2017, including information concerning the 1st year of project implementation, while the 2nd newsletter (Annex 10.2.58 D.6 Del 2nd Newsletter LIFE RE-WEEE _EL and Annex 10.2.59 D.6 Del 2nd Newsletter LIFE RE-WEEE _En) was released in August 2017, describing the project progress for the period of January – July 2017. The newsletters recipients are, among others, relevant stakeholders, including the Municipalities of the regions of interest, the corresponding departments of Ministry of Environment and Energy ("YPEN"), the RREUSE members, companies involved in WEEE treatment, the networking projects, the LIFE Communication Team etc. The project newsletters were also uploaded at the project website. Three spot videos for the promotion of prevention of WEEE production and EEE re-use are foreseen to be developed. Action E.3 is in progress according to the foreseen timetable. HUA is responsible for the Action implementation. The CFG is comprised of one representative from each beneficiary, according to the Project Organization Chart (Annex 10.2.126 E.2 Del Quality Assurance and Quality Control Handbook). The CFG members are responsible for the overall supervision, monitoring and assessment of the Project's carbon footprint, as well as for the development and implementation of activities, which will lead to the mitigation of the Project's carbon footprint. The Sub-actions are being implemented by a working group, which is assigned, guided and monitored by the CFG. Within the reporting period, one (1) meeting of CFG members and members of the working group, was held in Harokopio University at 13/6/2016. The meeting addressed the following issues: comments on the definition of the handbook content, the emission factors of equivalent CO₂ for the activities related to the project and the calculation of the Project activities' emissions. The participants list was provided as Annex 1.02.131 E.3 Participant list of CFG meeting with the MTR.

Throughout the reporting period, the following activities per Sub-action were conducted:

<u>Sub-action E.3.1</u> included the development of a handbook (Annexed as 10.2.130 E.3 Del Handbook of CO2 emissions estimation) to facilitate the estimation of the Project actions' CO₂ emissions. The guide includes the definition of the Project's activities which have to be considered for the calculation of the CO₂ emissions, and their functional limits. The operation of the two sorting centers will be taken into consideration for the calculation and monitoring of the project's carbon footprint. However, it had not been included in the first version of the Handbook, because the operation parameters of the sorting centers had not been defined when the handbook was delivered. Upon EC remarks (EC Letter Ref. Ares(2017)2235438-02/05/2017), a short description for monitoring carbon footprint of the sorting centers operation has been added in the Handbook. The description will be revised when the operation of the sorting centers start. Accordingly, the CO₂ Factors excel file will be updated.

<u>Sub-action E3.2</u> was based upon the guidelines of E.3.1. The CFG and the working group identified – by the means of literature research - the factors that will be used for the "interpretation" of each activity into CO_2 emissions. The factors are presented in excel file (Annexed as 10.2.132 - 10.2.126), which accompanies the guide for the estimation of the Project actions' CO_2 emission. The CFG is responsible to periodically review and – if needed – modify them.

<u>Sub-action E3.3</u> includes the collection of data about the activities of each Action by the CFG and/or the working group of E.3, which should be considered for the calculation of CO_2 emissions, throughout the reporting period. For instance, in the case of travel, data about the distance, the transportation means, and the meals were recorded.

The collected data was utilized in order to calculate CO₂ emissions according to the following formula:

[Data of a certain activity] * [factor of emissions] = $[CO_2 \text{ emissions}]$.















During the reporting period, no major issues have been encountered during the implementation of Action E3. The 1st annual report (year 2016) for the project's carbon footprint was delivered in the first ten days of January 2017 (instead of the end of December 2016), in order to include the last days of December 2016 and submitted as Annex 10.2.133 E.3 Del 1st annual report for the project's carbon footprint in the present report. In accordance, the 2nd annual report (year 2017) for the project's carbon footprint will be delivered in the first ten days of January 2018 (instead of the end of December 2017),

Delays

The draft version of the handbook was delivered to the CFG in March 2016 for remarks and comments. The handbook was completed by early April. However, during the 1st meeting of the CFG members and members of the working group (13/06/2016), minor revisions were made concerning mainly the definition of the factors. This short delay as well as the minor revision had no impact on the Project's implementation, as the draft versions of the guide and the excel file were functional, providing reliable results.

Deviations from the foreseen timetable were addressed during individual Actions' progress and the management groups of the Project tackled them sufficiently. The delays that have occurred have no impact to the overall progress of the Project.

The problems that the Project team faced concern technical and financial issues and are described in detail at the relative chapters. A brief description of most remarkable problems are referred below:

Technical issues:

- 1) The Project team decided to release an integrated questionnaire concerning Actions A.1 and sub-action B.1.1, since a target group of stakeholders was common. Afterwards, in countries where prevention of WEEE production and preparing for re-use procedure are in early stage (such as in Greece and Serbia), the integrated questionnaire could not be answered, as specific data concerning procedures of preparing for re-use cycle were requested (such as number of employees, quantities of reused equipment etc.). HUA, the responsible beneficiary for Action A.1 implementation proceeded in releasing of a modified questionnaire, after approval of the Project team, to facilitate the collection of more relevant data corresponding to Action A.1.
- 2) A delay of 5 months has occurred in Action B.5, concerning the call of interest for the site selection in order the two (2) SCs to be settled down and to operate. The Project team faced several obstacles, due to the fact that SCs operation is innovative in Greece and the National legislative framework (M.D. 1958/2012) for the definition of the environmental permit and procedures required for the authorization of such type of facilities was not sufficient by the start of the project. Therefore, after HRA's communication with the Department of Recycling - Alternative Management of the Ministry of Environment & Energy (YPEN), a modification proposal by the second was issued to the corresponding Department of Environmental Authorization of "YPEN" and proceeded in amendment of the framework as MD 37674/2016 (7.2.16 M.D. 37674/2016 (ΦΕΚ 2471/B/10-8-2016)), in order to classify SCs in the relevant group of facilities and to define the specific environmental authorization requirements and procedures. Detailed description of the above legislation amendment procedure is referred at the corresponding Action B.5, at the Technical part of the present report.
- 3) Additionally, the current National Land Use Planning restricts the settlement of waste management facilities such as SC, outside the districts of the defined Urban Plan or inside industrial areas accordingly. To address the restrictions of SCs settlement, attempts took place by LIFE RE-WEEE Project Team, represented by HRA, through communication with the General Secretariat for Regional Planning and Urban Development of "YPEN", in the context of the development of spatial planning framework of Green Recycling Centers, in order SCs to be allowed settled down within the Urban Plan's districts, combined with Green Recycling Centers or in adjacent sites, thus the citizens could be also served by SCs (7.2.14 B.5 Proposal for SCs spatial framework - e-mail). However, the combination of spatial planning framework of

















Green Recycling Centers with SCs was not feasible due to the activities that take place in SCs. Therefore, the Project Team proceeded with the current legislative spatial framework, to avoid further delays. However, the Project Team continues to make efforts for the spatial planning of SCs with the cooperation of the General Secretariat for Regional Planning and Urban Development of "YPEN", to facilitate the development of further SCs, outside the Project's framework. As the restriction of SCs settlement outside the districts of the defined Urban Plan or inside industrial areas results in limited availability of proper infrastructures for SCs operation, delays concerning the definition of the required technical specifications of SCs that constitute part of the Management plan had been occurred, in order to be in compliance with the National framework of authorization. The addressed restrictions are described in detail in the corresponding Action B.5. This delay does not affect the overall progress of this Action, as the determination of the final proper SCs operation specifications are important for the expected results of the Project.

- 4) After the technical requirements of SCs definition and the submission to the BoD of GF, a period time of 2,5 months was required for the approval of the final technical requirements of SCs, according to the internal procedures of GF that is responsible for the tender constitution, and therefore the call of interest inception, that constitute Project milestone, was launched in February 2017 and the deadline for the proposals submission was firstly set on 10/4/2017. The lack of proposals submission till the aforementioned tender deadline led to the decision of the GF BoD for tender prolongation for a period of one (1) month. Details on the proposals submission are described at the corresponding Action B.5.
- 5) The delay of the call of interest process resulted in six (6) months delay of the announcement of the tender procedure for the contractors' selection. Moreover, the fact that no result for the case of the Attica region was carried out concerning a Municipality selection for the SC operation, led the project team to proceed in an alternative scenario for the sub-action B.5.2 implementation, after the guidance of TMO and the approval by the Project Adviser of EASME, as described analytically at the corresponding Action B.5 of the present report.

The delays at individual actions of the technical part of the project are not expected to affect the proper implementation of the project.

The most significant constraints were faced in the context of the Action B.5 implementation and are described in detail at the chapter "6. Technical part". Among the main objectives of the project is the installation and demonstrative operation of SCs that take place for the first time in Greece. The faced difficulties and constraints demonstrated the deficiencies in settlement issues and environmental permits of SCs. The project team managed to achieve amendment at the current national legislation for environmental permit and in parallel contribute to overcome the settlement issues and to attempt to achieve, with the collaboration of the competent authorities, a legislative framework for SCs operation after the project completion.

Financial issues:

Personnel budget concerning GF partner is divided between permanent and additional staff. The GF is composed of seconded employees from other public bodies and according to the National Law 3889/2010, amended by the Law 4030/2011, employees'

















paid salaries are by the organisations of provenance. According to the Monitoring team response (email 13/4/2016), since personnel costs of GF permanent staff are incurred by another entity, then this is considered an 'in-kind contribution' and therefore are not eligible. This issue was confirmed also at the Annex - Financial Issues No 9 of letter from EASME by 11/7/2016 concerning the Monitoring Team visit. The additional staff employments were initiated in June 2016. For this reason, personnel costs of GF employees are deviated downwards from the foreseen budget.

6.3 **Evaluation of Project Implementation**

As pre-described in the chapter "5. Administrative part", the ACP and the three supporting groups monitor the smooth progress of the project. Since some barriers were faced mainly within the implementations of "Actions B", the project team made efforts to overcome the difficulties. The corrective actions are referred below briefly (the detailed description of each barrier is performed at each corresponding Action and in chapter "6.2. Main deviations, problems and corrective actions implemented"):

The indicators of project progress based on the objectives of each Action are referred at the tables "Comparison with established targets" at the description field of each Action. Based on these tables, and on corrective actions that took place within the project implementation, the overall progress of the project is evaluated as successful. Although these delays in the selection of the two SCs, the arrangements on legislative issues concerning the operation of sorting facilities, as described above, facilitate the sustainability of the project results and are evaluated as successful. The project team faced with flexibility the barrier concerning the end of the call of interest for the Municipalities selection with no results in the case of Attica region and proposed an alternative implementation scenario (details in Action B.5 description) of subaction B.5.2, which was approved by Project Adviser, in order to overcome this obstacle.

















Moreover, since the calculable Project Specific Indicators refer mostly to dissemination activities, the stakeholders and public that have been informed for the project objectives and results to date, have overcome the foreseen number of individuals that had been set on the submitted Project Specific Indicators in the proposal. However, the impact of the project on the public and also on stakeholders is estimated to be visible after the operation of the donation/exchange platform and the operation of the two SCs. The contribution and the activity of the public through the platform will lead to calculable results in the prevention of WEEE production in Greece. In addition, citizens and local authorities' acceptance concerning the operation of the SCs will result firstly in the increased interest of citizens to visit the SCs facilities and on the other to the increased interest on behalf of local authorities to develop sorting facilities within their boundaries.

As described in detailed at the charter "6.4 Analysis of benefits", LIFE RE-WEEE targets are in compliance to the existing EU targets and priorities, concerning reduction of wastes and maximization of re-use. The objectives of the project fall also under the new EU Action Plan for the Circular Economy and its basic principles. Moreover, the project resulted in amending legislation concerning the environmental authorization of SCs and contributed to the legislative framework development for the spatial planning of these facilities, as described in the chapter "6.2 Main deviations, problems and corrective actions implemented". Additionally, in the context of LIFE RE-WEEE actions, technical requirements and specifications for preparing for re-use are being developed within the project duration, based on current European standards and specifications, and will be proposed to the Ministry of Environment & Energy aiming to eventual integration in the National legislative framework. The implementation of the project's action comply with the EU policy concerning the prevention and preparing for reuse fields. The operation of the SCs -for the first time in Greecethe development of specifications and technical requirements for the overall procedure of preparing for reuse and the activities concerning public awareness regarding the prevention of WEEE production give added value to the project. Through these actions, the project team takes the advantage to apply the EU principles in Greece, contributes to the development of new "green jobs" and sets the baseline for the operation of sorting facilities not only in the wider area of Greece, but also in other countries at very low stages in the field of prevention and preparing for reuse, by replicating and transferring the results of the project. The aforementioned results will be mostly visible at the end of the project, during the "After Life" period where the calculable results will be measured and disseminated.

6.4 Analysis of benefits

The LIFE RE-WEEE Project aims at the reduction of WEEE, through the implementation of prevention (reuse) and preparing for reuse actions and will contribute towards the shift to a circular economy. To achieve this, it involves the development and operation of the two SC, and on the other the development of the web-based platform for exchanging/donation of WEEE. The two SCs, the first of their kind in Greece, will sort 1,000 tn and 500 tn of WEEE per year in Attica and Central Macedonia, respectively. It is estimated that by the 1.500 tn of income WEEE in the SCs, 310 tn (mostly from categories 5 and 6 of WEEE according to Annex III of KYA 23615/651/E.103) will be addressed to preparing for reuse process, annually. The operation of the SC is estimated to result in a GHG reduction of 5,470 CO₂ eq tn/yr, due to limitation of new appliances production, or to recycling operations in case this quantity of WEEE would be led to treatment facilities rather than to be reused. Furthermore, preparing for reuse of the aforementioned quantity of WEEE is estimated to result in significant savings of heavy and precious metals and other raw materials used for the production of new appliances















that are harmful to human and environment or are of high economic interest, such as ferrum (51 tn), copper (106 tn), gold (6 kg) etc.

In an effort to promote Electrical and Electronic Equipment (EEE) donation and exchange at the consumer lever in Greece through operation of the platform Re(W)eee, it is anticipated to at least 1,000 EEE items will be exchanged/donated, corresponding to the prevention of 1,650 tn WEEE production (estimated in terms of the expected WEEE generation per capita, i.e. 0.1 kg/cap, and the current population of Greece: 11,000,000 inhabitants).

1. According to RREUSE, 1,000 tons of WEEE prepared for re-use would create 35 "green jobs" compared to 7 jobs if it was dismantled. The jobs corresponding to reuse and preparing for reuse procedures include activities relevant to collection, transportation, sorting, repair and selling of prepared for reuse equipment. This fact entails the creation of jobs in a variety fields and demanding employees with variety educational/ training levels.

Based on the above data, the operation of the two SCs through the sorting activities of 1,500 tons per year and preparing for reuse of 20% of income WEEE to the SCs resulted in creation of 10.85 full time equivalent (FTE) jobs, involved in the overall preparing for reuse cycle, and thus to a significant economic impact raised by the project. The main objective of the project is to disseminate the results, following the demonstrative operation of the SCs, in order for more SCs to be installed and operate in the wider region of Greece, for WEEE and for other waste streams in future. Hence, a field of more new jobs will be created contributing to the enhancement of the national economy.

Furthermore, the SCs, after the sorting activities of the incoming WEEE, could supply commercial and social economy actors active in the fields of repairing, refurbishing and selling of reused WEEE with good quality "raw materials", to facilitate their activities and the market release of high quality reused appliances in favorable prices.

In addition, savings in metals and other raw materials (such as plastic, glass etc.) that resulted in reuse and preparing for reuse activities that take place within the project implementation, as well as the promotion of these activities, compared to the consumption of these materials needed for the production of new equipment or recycling activities, impacts to a certain extent on the global economy.

2. The social benefits arising by the project implementation are directly connected to the economic impact of the project. The creation of new "green jobs", as described above, are among the most important social benefits resulting from the project actions, since the employment opportunities are increased in a country that "suffers" from elevated unemployment. Furthermore, the creation of new green jobs could be the path for the organization of new training programmes by the Labor Force Staffing Agency in Greece (OAEΔ), to boost labor market reintegration of unemployed and socially disadvantaged groups. The fact that social enterprises can manage the operation of the SCs, as pre-described, new jobs will be created for the scope of these enterprises activities, and according to their status, more people coming from socially disadvantaged groups will have more employment opportunities. Furthermore, social enterprises that are related to the WEEE service and refurbishment, provide good quality of reused equipment to people with low subsistence level at low prices.

In addition, social benefits are directly linked to environmental impact of the project, concerning the reduction of the greenhouse gasses, the reduction of wastes and consumption of raw materials. The quality of life and health of citizens strongly depends on the quality of the urban environment.

3. The potential benefit of the project is the fact that the results could be replicated and transferred to other regions of Greece, but also to other European countries. More specifically, the development of specifications and technical requirements for the overall preparing for reuse

















procedure is based on European standards and current Best Available Techniques (BAT) and developed specifications in other European countries. The developed specifications will be applied during the demonstrative operation of the two SCs and afterwards, will constitute the base for the National legislative framework for the operation of such facilities at first, and will be potential prototype for the development of corresponding specifications in other EU countries that preparing for reuse of WEEE is at a primary stage.

The operation of the two SCs is developed in a sustainable base. The project team targets to disseminate the results after the demonstrative operation of the SCs, in order to continue to operate after the project implementation, and to attract other stakeholders for the operation of other corresponding facilities in the wider region of Greece, since many Municipalities had already declared interest in developing sorting facilities not only for WEEE, but also for other solid waste streams.

In addition, the methodology for the prevention and preparing for reuse measurement of WEEE has the potential benefits to provide a harmonised methodology at EU level and allow for the EU to have a preparing for re-use target which would be separated from the recycling target. This potential target would save a lot of EEE from waste and would create a significant amount of jobs at EU level.

The RREUSE members will contribute to the replicability and transferability objectives of the project, through the RREUSE WEEE working groups that will take place during the project. Moreover, to disseminate the results of the project in order to be applied in other EU countries that are at a primary stage of preparing for reuse, two workshops are foreseen to be organized by RREUSE in Poland and Slovenia.

4. LIFE RE-WEEE is a demonstrative project aiming to implement preparing for reuse of WEEE activities in Greece, for the first time. As well it will contribute to the configuration of a National legislative framework for the whole cycle of preparing for reuse procedures and to the development of measurement and assessment methodologies of the environmental, and socio-economic impact of reuse.

The development of the technical requirements and specifications regarding all the activities of preparing for reuse of WEEE (Action B.4), is based on existing European standards and specifications (e.g. WEEE Labex, CEN-CENELEC). The developed specifications will potentially constitute the base for the development of Best Available Techniques (BAT) concerning Greek practices.

Moreover, recording and assessment of existing measurement methodologies of prevention and preparing for reuse (Action B.1) applied in some EU member-states will facilitate in the development of a new integrated methodology and measurement tool aiming to be transferred and applied at European level, even to countries that are currently activated in the field of preparing for reuse activities.

5. The innovative character of the project relies in the fact that actions regarding prevention and preparing for reuse of WEEE take place for the first time in Greece in an organized manner, since till today only individual not-calculable actions have taken place. For this reason, the recording and measurement of prevention and preparing for reuse of WEEE is in the scope of the project, with an innovative measurement methodology, based on the existing methodologies applied at other EU state-members that are advanced in that field. The project aims to develop a transferable and usable measurement tool at EU level.

In addition, the development of technical requirements and specifications for the overall cycle of preparing for reuse of WEEE and, by extension, the base for the National legislation framework for these procedures are innovative for Greece, and comply with the European legislative targets. Since Greece is at a primary stage in the sector of preparing for reuse, the developed specifications could be transferred to other counties of the same level in that field.















Furthermore, the installation and operation of the WEEE sorting facilities for the first time in Greece, breaks new ground in the field of WEEE management, since through the demonstrative operation of the two SCs the sustainability of the SCs operation will be assessed. This will result in the instalment of new sorting facilities in the wider region of Greece, but in the sorting activities in other solid waste streams as well.

To achieve the aforementioned objectives, organizations that occupy key-roles in the WEEE management were incorporated, among others, as beneficiaries of the project. More specifically, HRA, the competent authority of the Ministry of Environment & Energy for the design and implementation of recycling policy in Greece, "Appliances Recycling S.A.", the official collective system that organises, operates and controls the collective system for the alternative management of WEEE in Greece and RREUSE, the European organization that represents social enterprises active in re-use, repair and recycling.

6. LIFE RE-WEEE targets are in compliance to the existing EU targets and priorities, concerning reduction of wastes and maximization of re-use, as prescribed in the current EU legislation and the 7th Environment Action Programme (EAP) to 2020. The objectives of the project fall also under the new EU Action Plan for the Circular Economy and its basic principles.

Although, LIFE RE-WEEE Project is in line with the EU targets, obstacles were addressed concerning the development of SCs, since the existing National legislation framework did not provide the specific requirements for the appropriate environmental authorization of these facilities

However, as described in detail at the chapter "6.2 Main deviations, problems and corrective actions implemented" and at the corresponding Action B.5, the Project Team tackled these restrictions when feasible. More specifically, after cooperation of HRA, representative of LIFE RE-WEEE, and the Department of Recycling – Alternative Management of YPEN, amendment of M.D. 1958/2012 by M.D. 37674/2016 was achieved. SCs were classified in the relevant group of facilities and included in Group 4 "Environmental Infrastructure Systems" as "Sorting Centers of Electrical and Electronic Equipment (WEEE) - Including facilities for preparing for reuse of WEEE (category "97"). Moreover, current National legislation puts restrictions in settlement of waste management facilities (collection, sorting, storage, treatment, disposal etc.), such as SC, outside the districts of the defined Urban Plan, according to PD 31/1985, or inside industrial areas according to PD 166 D/1987. For this reason, LIFE RE-WEEE Project, represented by HRA, made efforts in order SCs to be included at the same spatial framework with Green Recycling Centers with the cooperation of the General Secretariat for Regional Planning and Urban Development of YPEN. Due to the activities that take place in SCs, a special spatial framework for SCs is under development with the contribution of the LIFE RE-WEEE Project, in order to facilitate the development of further SCs, beyondthe Project framework.

Additionally, in the context of LIFE RE-WEEE actions, technical requirements and specifications for preparing for re-use are developed within the project duration, based on current European standards and specifications, and will be proposed to the Ministry of Environment & Energy aiming at the eventual integration in the National legislative framework.















7. Project Specific Indicators

The overall revised table of the Project Specific Indicators within the reporting period is annexed in the corresponding Action E.2 as Annex 10.2.128 E.2 Del Validation of Project Specific Indicators.

As it was described in Action E.2, the indicators concerning the "Governance", "Information and awareness" and "Capacity building" fields have been revised and comprise calculable data raised within the reporting period. Only the described indicators above are examined till the current period. "Table 20 Table of Indicators" gathers all the collected data, focusing in the fields of interest.

The comments marked with orange colour refer to the revised fields. The column "State-ofplay at the progress reporting period till 30/09/2017" refer to the collected data within the reporting period.

It is assessed that the set indicators, concerning the described fields, constitute achievable indicators, and in some cases have already been exceeded (e.g. "other media (video/broadcast")), even though the project progress approaches the 2nd year of implementation. The QA/QC Group, which is responsible for monitoring the Project's progress and to collect all data relative to the overall project progress assessment, aims to achieve the set indicators or to revise them in case of not responding to real data. The other indicators do not fall in the reporting period of the present report, due to their connection with the SCs operation or the donation platform. No data could be collected, for example, concerning waste prevention, and therefore reduction of CO2 emissions, as corresponding activities are foreseen to be implemented at the end of the 2nd year of project duration.

Till the next Progress Report that is foreseen to be submitted in June 2018, the following <u>key deliverables</u> will be implemented:

- The methodology for the measurement of preparing for reuse and reuse will be almost developed, in order to be implemented at the SCs. The RREUSE members will contribute to the optimization of the methodology and how applicable this measurement tool could be.
- The inventory of current situation in Greece concerning the individual activities on preparing for reuse and reuse in Greece is foreseen to be completed on March 2018. Moreover, the impact of financial crisis to the production of WEEE in Greece is foreseen to be reported till June 2018. The recorder data of the above reports will facilitate the development and implementation of proper initiatives and practices for prevention of WEEE production and the overall procedure for preparing for reuse activities.
- The two SCs will operate according to the specifications and technical requirements developed in the context of the LIFE RE-WEEE project, concerning the overall activities of preparing for reuse procedure and the proper equipment procured by the project as foreseen. "Appliances Recycling S.A." will drive the foreseen quantities of WEEE, according to the GA, to the two SCs, in order to collect calculable results on preparing for reuse activities.
- The exchange/donation platform Re(W)eee will be accessed by public for a period of 5 months till the next Progress Report. The partners of the project will distribute the platform through dissemination activities and social media. The first repair event "Μαθαίνω να επισκευάΖω" will be organized promoting the culture of repair and prevention of WEEE production. The Quick Repair Guide will facilitate the conduction of the repair events.
